Keynote Address: What the Courthouse Represents: Dignity, Independence, and Impartiality

Location: International Center North

What does the physical configuration of a courthouse have to do with the delivery of justice? If the design of the building does not adequately support the process of caseflow management, it actually can delay trials, cause mistrials, and, at its worst, enable clever in-custody defendants to escape. Learn how court space can be utilized to enhance the appearance of justice and actual justice.

Integrating Courthouse Security through Transparent Design (AIA partnership)

The level of building security design and transparency is picking up momentum in our public buildings. In the time since Oklahoma City and 9/11, where the public are more aware of their surroundings and security measures in public spaces, when does “in your face” security become visibly overwhelming? This track explores the current evolution of security design ideas in perimeter site design, interior planning, and systems designs, which are highly effective but not intrusive to the architecture and to the public experience. With so much emphasis on security in public buildings, civic designers are increasingly challenged to design a welcoming building that integrates appropriate security measures. Current design ideas and planning concepts seek to integrate new, more stringent security guidelines into our public buildings in such a manner that is not obtrusive, obvious, or restrictive.

The Infrastructure and Practices of the Green Court

No one in modern society can escape the intense interest in conserving natural resources, reducing our “carbon footprint,” and improving energy efficiency. As we improve existing or design new courthouses and facilities, the environment will be a major consideration. The green movement goes beyond buildings and encompasses transportation, recycling, and the use of paper and technology, among a host of other factors. This workshop will provide attendees with the opportunity to discuss with an administrative and architectural panel some of the major facets of a green court in what served as the basis for the latest NACM publication, Achieving and Sustaining the Green Court. The guide, in particular, addressed a myriad of areas on how a green court initiative can be started and then sustained over an extended period of time to save money, resources, and the environment.

Alternative Funding Options for Court Facilities

Court facilities, such as courthouses, juvenile detention buildings, probation and client program offices, satellite service centers, and general purpose buildings, either operated by the judicial branch or provided to trial courts by a “host government” (i.e., cities, counties, or states), are focal points of the justice system and important symbols of the Rule of Law. Yet many facilities also portray a bleaker image—a picture of neglect, decay, or obsolescence. Raising the need to improve court facilities as the first step toward solutions is familiar territory for most court leaders and managers. However, the next critical stage often has the potential to scuttle or delay the best of plans and intentions—raising the money. This session will explore various funding options from bonds to fees to charitable contributions to nontraditional partnerships that have been creatively used to fund capital projects to expand and renovate existing court buildings; purchase furniture, fixtures, and equipment for them; or construct new facilities. The times undeniably call for innovative approaches.

Exemplary Court Design: AIA Award Winners (AIA partnership)

The AIA/AAJ (Academy of Architecture for Justice) publishes an annual review of exemplary design of justice facilities. This year’s NACM representative, Virlynn Tinnel, will join AAJ Advisory Group member Frank Greene, FAIA, in presenting the selected courthouse projects and discussing the factors that distinguish these excellent projects. Topics such as innovative operational concepts, imagery as a reflection of community values, and sustainable design will be illustrated in the project case studies, enhancing their real-life applicability to NACM members.

This is a nontechnical program for nontechnical court leaders that will

focus on a nontechnical, three-dimensional framework for securing resources that are critical to court operations. Find out how to prevent, detect, and repair technology problems related to security. Did I mention that this is a nontechnical program? You will learn and you will have fun!

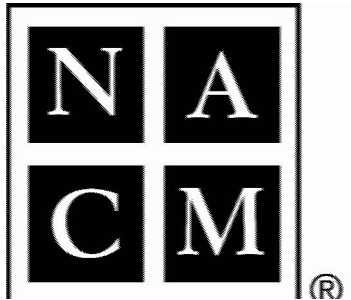
Is your court struggling with space problems? Meeting the space needs of the court is a constant challenge, and Court Administration may find that help is needed. Architects are space professionals and can provide invaluable services, but there is much that Court Administration can and should do before the architect is hired and the architectural process begins. This session is intended to help you as a court administrator to recognize space as a resource to be managed; create a strategic rather than a stopgap approach to space planning and design and renovation projects; establish in advance the functional vision needed to guide the architect and architectural process; understand the implication of court processes on space needs; define the service-delivery interests and spatial guidelines that should be met to best support the work of the court; identify the space-planning information and tools you need to build a successful space management plan; determine priorities; secure the support of the court for a strategic space plan; and secure the understanding and support of the funding source for design and renovation projects. Learn how to be ready for and get the most out of the architect and the architectural process and how to make both truly support the work of the court.

Putting Theory into Practice: Courthouse Security in Colorado
